Volleyball World is looking for organisers to host the FIVB Beach Volleyball World Championships in either 2023, 2025, 2027 (the “Event”).

The FIVB Beach Volleyball World Championships is the pinnacle event of Beach Volleyball, where the best 48 teams per gender compete over a period of 10 days in a multi-city or multi-venue event.

VW is looking for potential organisers: National Federations and/or private or public entities, having an interest in hosting the FIVB Beach Volleyball World Championships (“Organiser”). Should the Organiser not be or not include a National Federation, Organiser must be in a position to secure the National Federation endorsement.

For the avoidance of doubt, this document constitutes purely a declaration of interest and is not intended to create any binding obligation on the part of either VW and/or the Organiser.

In particular, the invitation by VW to submit this Expression of Interest does not constitute a binding offer on the part of VW to grant the right to stage the Event, nor does it create any obligation on VW's part to actually engage in actual negotiations with the Organiser following receipt of this completed document.

On the Organiser's part, the submission of this Expression of Interest does equally not constitute a binding offer to stage the Event. It is a purely and solely a confirmation given in good faith of an actual and serious **interest and capacity** to do so based on the information provided by VW at this stage.

Any issue arising out of or in connection with this Expression of interest between VW and the Organiser shall be governed by Swiss Law.

In the unlikely event a dispute which could not be amicably resolved would arise, such should be exclusively settled by arbitration in accordance with the Code of sports-related arbitration of the Court of Arbitration for Sport in Lausanne. Absent an immediate agreement of the parties, the sole arbitrator shall be appointed by the CAS. The proceedings shall be conducted in an expedited manner, solely in writing and without a hearing.

1. Expressions of interest are to be received from Now until November 30th 2021
2. VW will evaluate applications and invite selected parties to officially submit a bid (candidates will be advised of bid requirements)
3. Host for the 2023 FIVB Beach Volleyball World Championships will announced by February 1st, 2022


